A RESOLUTION OF THE WASILLA CITY COUNCIL AUTHORIZING A FEE STRUCTURE FOR LAKE LUCILLE PARK RELATED TO THE CITY OBTAINING OPERATION AND MAINTENANCE AUTHORITY FROM THE MATANUSKA-SUSITNA BOROUGH FOR THE PARK.


WHEREAS, the City of Wasilla has received temporary authority from the Matanuska-Susitna Borough to operate and maintain Lake Lucille Park until a 50 year lease agreement can be finalized with the Borough later this year; and

WHEREAS, the Borough's fee structure needs to be adopted for City use to help fund the operation and maintenance of the park as follows:

NOW, THEREFORE, BE IT RESOLVED, by the Wasilla City Council that the above described fee structure is hereby adopted for Lake Lucille Park.

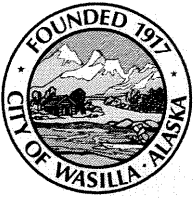


