Summary Statement: This contract award is in response to the City's Request for Proposal No. 0215-0-2019/AG for Wasilla Historic Development Professional Services. This RFP included 3 tasks as follows:

Task 1-Historic Town Site Parking Lot Development Task 2-Tryck House Relocation Task 3-Train Station Building Relocation

The City received two proposals for this work and the proposal submitted by PND Engineers was evaluated and determined to be the top ranked proposal. Tasks 1 and 2 are proposed to be awarded through this Action Memorandum while Task 3 will be awarded later this year.

Staff Recommendation: Adopt AM No.19-14.

REQUEST FOR PROPOSALS WASILLA HISTORIC DEVELOPMENT PROFESSIONAL SERVICES SCOPE OF WORK

Task 1- Historic Town Site Parking Lot Development

This is proposed within the south one-half of Lot 8, Block 8, Wasilla Townsite, at 401 E. Herning Ave in Wasilla. This is the former site of the Jake Wright Fire Hall on the corner of Main Street and E. Herning Ave.

The selected design team will develop plans and bid documents for a new parking lot at this site. Services include obtaining a Land Use permit from the City of Wasilla and landscaping as part of the project. Surveying will be provided by the City of Wasilla. This work is planned for the 2019 construction season.

Task 2- Tryck House Relocation

This house is located on Lot 1, Block 3, Wasilla Townsite, at 291 E. Parks Highway. This is a small single-story wood structure that the City wants to preserve and relocate to the Menard Center. The Menard Center currently has a historic log cabin onsite, and the Tryck House is proposed to be an addition to the log cabin for activities and events. The owner has agreed to donate the building to the City of Wasilla.

The selected design team will develop plans and bid documents to move the structure onto a new foundation at the Menard Center. Services include obtaining a Land Use permit from the City of Wasilla and a Building Permit from the Fire Marshall for this project. Surveying will be provided by the City of Wasilla. This work is planned for the 2019 construction season.

Task 3- Train Station Building Relocation

The Wasilla Train Station is on the National Historic Register and it is currently used by the Wasilla Chamber of Commerce, located in railroad right-of-way at the corner of Knik-Goose Bay Road and the Parks Highway. This is the current train stop in Wasilla, and train stop needs to be relocated as part of the DOT Main Street Couplet project. The City of Wasilla acquired Parcel A6 approximately one-half mile east of the current train stop to develop a new train station facility.

The selected design team will develop plans and bid documents to move the Historic Train Station Building onto a new foundation at the new site. Plan development includes connecting the building to an existing onsite well, connecting the building to a new onsite septic system, and the connection of gas and electric utilities for a fully functioning building. Services include coordination and permitting from the Alaska Railroad for removing the building from its current site in railroad rightof-way, obtaining a Land Use permit from the City of Wasilla and Building Permit from the Fire Marshall for the new site. Surveying will be provided by the City of Wasilla. Design and permitting are planned in 2019, with building relocation planned in 2020.
