An Ordinance Of The Wasilla City Council Authorizing The Sale Of Lot 2, Broadview Acres In The Amount Of \$115,000 To A&A Commercial LLC, Under Wasilla Municipal Code 5.32.060(B), Council Approval; Authorizing The Mayor To Execute And Deliver A Contract For The Sale; And Providing For Related Matters.

WHEREAS, the City of Wasilla advertised the referenced parcel for sale through its

February 27, 2019 invitation to bid; and

WHEREAS, A&A Commercial LCC provided the highest qualified bid in the amount of

\$115,000; and

WHEREAS, WMC 5.32.030 Appraisal Required, states that no land shall be sold or

exchanged for less than the approved minimum appraised or assessed value; and

WHEREAS, the current Matanuska-Susitna Borough assessed value for the referenced

parcel is \$111,600; and

WHEREAS; the referenced parcel is not needed for a public purpose and the sale is

supported by the Wasilla Planning Commission through Resolution Serial No. 19-04.

NOW, THEREFORE BE IT ORDAINED, by the Wasilla City Council:

Section 1. Classification. This is a non-code ordinance.

Section 2. Authorization of Sale. Based upon the information stated above, the City is authorized to sell Lot 2, Broadview Acres in the amount of \$115,000 to A&A Commercial LLC.

Section 3. Authorization of Purchase and Sale Agreement. The Mayor is authorized, empowered and directed to develop with the counterparty a Purchase and Sale Agreement on behalf of the City, and from and after execution and delivery of said document, the Mayor is hereby authorized, empowered and directed to carry out and comply with provisions of the agreement.

Section 4. Authority of Officers. The Mayor is authorized and directed to do and perform all things and determine all matters not determined by this ordinance, to the end that the City may carry out its obligations under the Purchase and Sale Agreement and ordinance.

Section 5. Effective date. This ordinance shall take effect upon adoption by the Wasilla City Council.


