SUMMARY STATEMENT: This ordinance accepts and appropriates E-911 surcharge funds as an alternate revenue source for dispatch services. E-911 surcharge monies are designated by statute to be used for costs associated with enhanced 911 systems. The Matanuska-Susitna Borough Enhanced 9-1-1 Advisory Board designated \$90,000 for payroll expenses and benefits for the MatCom Public Safety Dispatch Center operated by the City of Wasilla.

The intent is to designate the E-911 monies as alternate revenue sources in the funding formula as agreed upon in dispatch services contracts administered by the police department.
