

Summary Statement: This ordinance is proposed to amend the FY2020 budget by appropriating \$110,000 from the capital projects, fund balance for operating and capital costs expected through June 30, 2020 for the new Wasilla Police Department Building. The building was found substantially complete at the end of February, and utility and insurance costs are being applied to the capital project account from March to June 30, 2020. In addition, as the city begins to occupy the building, minor building improvements are being identified that this funding will be used to accomplish. Lastly, this funding may be used to begin the design for the future police department garage.
