**Summary Statement:** This ordinance is proposed to amend the FY2020 budget by appropriating \$5,031 from the Curtis D. Menard Sport Complex fund, fund balance for storage building capital improvements. In 2019, the city completed the construction of a 2,400 square foot storage building for the Menard Center.
