

Summary Statement: This ordinance is proposed to amend the FY2021 budget by appropriating \$110,998 from the capital projects, fund balance for the new Wasilla Police Department vehicle garage. This ordinance appropriates the balance available of the total funding raised for the New Police Department facility. The total amount raised for the new police department through sales tax collection was \$13,220,998. The police department building was constructed on budget in the amount of \$12 million. The total project cost for the new police department vehicle garage is \$1,220,998.
