#### ADDENDUM I

  - B. Update Number 7: 032420: "Closure of the Menard Sports Center until further notice"
  - C. Update Number 11: May 26, 2020 "Menard Sports Center re-opens to the public"

This will not affect any other contractual obligations already in place, or other payment obligations to the City of Wasilla. All other terms and conditions not specifically noted in this contract Addendum between the City of Wasilla, Curtis D. Menard Memorial Sports Center, and Matanuska-Susitna School District shall remain legally binding throughout the duration of the contract.

**SUMMARY STATEMENT:** The Matanuska-Susitna School District (the School District) uses the Curtis D. Menard Memorial Sports Center (CMMSC) for five graduation ceremonies each year. As CMMSC does not have sufficient equipment to deliver quality sound, the School District must rent equipment from an external source, at a cost of approximately \$3,500 per ceremony. Additionally, there is the inconvenience of setting up and dismantling the equipment after each ceremony. Based on the rental cost and inconvenience, the School District is incented to purchase and install high-quality audio and visual equipment into CMMSC. The value of the equipment with installation is estimated to be approximately \$77,500.

The City has recognized the need for improved sound quality in CMMSC but has not had sufficient funds to purchase the quality of equipment that could be delivered under the proposed agreement. Under the proposed agreement, CMMSC would allow the

School District to use the facility for five days during the month of May for ten years. The normal charge to the School District on average is \$7,500 per year. Over a ten year period, this equates to approximately \$75,000. The remaining \$1,500 of value is a one-time, no-charge use of the facility in September 2011 for the administration and teacher conference. This will be the first District Administration-Teacher Conference held at a single time and place as no venue previously had been available to accommodate this event in one session. Note that these estimates assume no rate increase to this user for the term of this agreement. Any additional events held at CMMSC in excess of the five days referenced in the agreement would be charged out at the normal non-profit rate at time of use.

This arrangement benefits the School District significantly by eliminating rental costs of equipment over the ten year term of the agreement. The benefit to CMMSC is the marketability of the audio and visual equipment to events that are currently held there and events that would now consider CMMSC for their venue. It is expected that use of the equipment, if desired by the user, would be an additional charge; hence generating additional revenue. While the additional revenue is difficult to estimate, it is believed to be well in excess of the amount of facility use fees (\$7,500 annually) that would be offset under the proposed agreement. As the City would take ownership of the equipment, it would also be responsible for the repair and maintenance costs associated with it. The terms and conditions of the agreement require a five-year warranty on the equipment as offered through the vendor for parts and labor. Therefore, minimal repair and maintenance costs are anticipated in the initial years. Any costs that are incurred (replacement bulbs, etc.) in FY 2012 would be absorbed into the current approved FY 2012 budget.

This arrangement serves as an example of excellent collaborative efforts. The School District, that brings education into this community, is able to achieve remarkable savings while at the same time enhancing the marketability of CMMSC to deliver high caliber events to surrounding Borough residents while significantly enhancing local business revenue.

WHEREAS, the sound equipment and installation cost is expected to cost approximately \$77,500.

NOW, THEREFORE, BE IT RESOLVED, that the Wasilla City Council authorizes the Mayor to execute an agreement with the Matanuska-Susitna School District to accept high-quality audio and visual equipment and installation of the system into the Curtis D. Menard Memorial Sports Center in exchange for facility use of approximately \$76,500 over a ten year period.
