AN ORDINANCE OF THE WASILLA CITY COUNCIL AMENDING THE FY2010 BUDGET BY APPROPRIATING \$14,050 IN SUPPORT OF AN INCREASE TO THE SALARY OF THE MAYOR.

Section 1. Classification. This is a non-code ordinance.

Section 2. Purpose. To appropriate \$14,050 to the General Fund, Administration Department, in support of an increase to the Mayor's salary from \$75,000 to \$85,779.





SUMMARY STATEMENT: Introduced on July 27, 2009 Council Meeting, was Ordinance 09-56, "Amending WMC 2.16.070, Salary of Mayor", and presented on August 24, 2009 is Resolution 09-26, "Establishing the Salary of the Mayor as provided by WMC 2.16.070".

Contingent upon passage of Ordinance 09-56 and Resolution 09-26, this Ordinance would fund the increase to the Mayor's salary for Fiscal Year 2010 (effective July 1, 2009) to \$101,803.

It is the Finance Departments recommendation to approve this Ordinance and support the budget necessary in FY2010 to fund the Mayor's salary as specified in Resolution 09-26.
