**Summary Statement:** The City of Wasilla, through the Curtis D. Menard Memorial Sports Center, is to provide optimum service levels to the public as cost-effectively as possible, promote a healthy community, provide a safe environment and a quality lifestyle.

An established local intermediate adult hockey league has requested the Menard Sports Center to facilitate their 6-team intermediate hockey league for the upcoming 2020-2021 season. The request to amend the fiscal year 2021 budget is to pay referee fees for 69 League games and 12 end of the season tournament games at \$130 per game or \$10,530, and \$400 to cover trophies and awards. Fees have not been appropriated for the Fiscal Year 2021 Budget since this is a newly acquired league.

Projected revenue from the 15-player roster for 6 teams at \$375 per player is \$33,750, netting a positive net gain of \$22,820. All season games are played on weekends after 8:45 p.m. as not to interfere with any other youth or public activities. No additional staff will be needed. Players have their own jerseys. All players are insured under the US Hockey Association, and have agreed to follow all CDC, State and City guidelines for COVID-19.
