# VI. COMMISSION AND AGENCY REPORTS

# A. Friends of Wasilla Public Library

Ms. Jeanne Troshynski, President:

- spoke regarding the August 3, 2009, book sale;
- commented on the success of the summer reading program;
- noted that Target has donated \$3,000 for next year's summer reading program;
- stated that the next Library Steering Committee meeting will be held on September 1, 2009;
- spoke regarding a Rasmussen grant that the Library may be eligible for; and
- stated that Wells Fargo has donated \$6,500 for a community survey.

# B. Matanuska-Susitna Borough

Assemblymember Mark Ewing, District 4:

- noted that he had accepted a position to the Local Emergency Planning Committee;
- spoke to the history of the City's opinion regarding a Borough sales tax;
- added that the Borough is considering revoking the City's planning powers;
- noted that the Borough is considering an ordinance which would appropriate federal and state monies towards identifying historical buildings within the City of Wasilla;
- spoke regarding the criteria required for classifying a building as historical and the associated ramifications; and
- noted that the City has until December to make a standing, when at that point the ordinance will go back before the Borough Assembly.

# A. Public Hearings

MOTION: Council Member Harris moved to adopt Ordinance Serial No. 09-56.

MOTION: Council I

Council Member Larson moved a primary amendment to WMC 2.16.070, to strike the words "shall not be less than that of the highest paid department head, and" to read as follows "The Mayor's salary, subject to the availability of funds, shall incorporate a cost of living adjustment (COLA) based on the percentage change in the Anchorage Consumer

Price Index."

VOTE:

The motion passed with Deputy Mayor Holler, Council Members Hall, Harris, Larson, and Woodruff in favor and Council Member Cox in opposition.

Discussion ensued.

MOTION:

Council Member Hall moved to postpone Ordinance Serial No. 09-56 to a time certain of August 24, 2009, at which time a salary matrix shall be brought back setting the Mayor's salary at a grade 25, and to direct the City Attorney to bring back a substitute ordinance which states the Council shall set the salary of the Mayor ninety days prior to the filing period and that the Mayor's salary shall be effective for the term of the office according to the salary matrix.

Discussion ensued.

VOTE: The motion to postpone Ordinance Serial No. 09-56 to a time certain passed without objection.

2. **Ordinance Serial No. 09-57**: Amending WMC 16.12.020, Administrative Approval And Use Permits, to provide for notice of the right to appeal decisions of the City Planner, and amending WMC 16.16.040, Procedure For Commission Approvals, to provide for notice of the right to appeal Commission decisions.

The commission's decision may be made immediately following the public hearing portion of the commission meeting. The decision of the commission shall set forth the facts it finds relevant to its decision and the reasons for its decision, and notify interested persons, as defined in Section 16.36.010, of the right to appeal under Section 16.36.060. The effective date of the decision is the date the findings and the reasons are set out in writing and signed by the commission chairperson or the chairperson's designee."
