

Summary Statement: This ordinance is proposed to amend the fiscal year 2021 budget by appropriating \$20,500 for the Planning Department legal services. Legal services for the Planning Department include participating in Planning Commission meetings and providing legal support for appeals and code revisions. The FY2021 budget was adopted in the amount of \$18,000 for this account. Expenditures to date for are \$28,518 and another \$10,000 is estimated for legal services through June 30, 2021. Therefore, the administration is proposing an appropriation of \$10,500 to meet the deficit.

Proposed Action: Introduce and set the ordinance for public hearing.
