WATER WELLS

PART 1 - GENERAL

1.01 DESCRIPTION

The work covered by this section includes the furnishing of all materials, labor, equipment, and performing all operations for the construction of one (1) production well and one (1) observation well as shown on the attached Plan Sheet (1 sheets). This work shall generally include the following:


- 1. Mobilization and demobilization.
- 2. Drill and install one, 6-inch diameter observation well.
- 3. Drill and install one, 10-inch diameter production well.
- 4. Install well screen.
- 5. Well development.
- 6. Test pumping.
- 7. Install well grouting, well casing above grade and locking caps.

All work shall be accomplished in accordance with these specifications and attached drawings. If the OWNER has provided optional items to select project work from, it will be the OWNER's right to select the option best suited for the desired end product. No additional fees, cost or monies will be owed to the Bidder for options <u>not</u> selected.
