Summary Statement: Rave Smart 9-1-1 software is a means to provide community sourced data directly to 9-1-1 call takers automatically. These resources include frequent caller flagging and reports, first responder access, reduces negative impact of dropped calls, and provides a lifeline for those citizens who may be faced with communication impairments, and automatic integration and enrollment in the federal RapidSOS program.

Rave Smart 9-1-1 system was installed at Matcom in 2019 and is now due for contract renewal. The E911 Board has approved, and the city would request reimbursement annually. Choosing the 5-year contract renewal option, the City would save over \$21,000 through-out the life of the contract.

The total contract is for \$172,805 or \$34,561 per fiscal year. The FY2022 Adopted Budget supports this expenditure, however FY2023 through FY2026 is subject to the normal budget approval process.
