**Summary Statement:** The City of Wasilla is required under AS 26.23.060 to implement a working Emergency Operations Plan (EOP) for the protection and safety of its citizens in a disaster emergency. The City's EOP has not been updated since its adoption in 2004 (Resolution Serial No. 04-33).

The purpose of the EOP is to focus on pre-planning and preparation for major emergencies that may face the City, or a response to a disaster emergency that requires the efforts and coordination of city, borough, state, federal, and private resources.

Administration is proposing to purchase software from BOLDplanning to update the 2004 EOP with CARES Act funds. The project must be completed by December 31, 2021, in accordance with the grant requirements under the CARES Act.

The software purposed for purchase is a cloud-based solution that uses best practices for EOPs by:

- Requiring users to assign actual ESF (emergency support functions) or annex actions to department or position roles.
- Developing clear and concise team roles.
- Planning for contingencies with multi-tiered orders of succession and delegation of authorities.
- Providing a file repository for redundancy in case of loss of internal drives or backups.
- Utilizing a built-in emergency SMS and email messaging system that reinforces resiliency and communications ability.

• Tracking and monitoring all version changes in our plan with advanced editor capabilities.

BOLDplanning requires a fee for EOP Module Licensing (year-one) and a 12-month subscription. Implementation of the software is estimated to take eight to twelve weeks.

After the initial investment \$24,920, the City can expect a \$6,558 annual maintenance fee to be approved through the annual budgeting process.

**Staff Recommendation:** Approve the Action Memorandum.


