Summary Statement: This Ordinance is proposed to amend the fiscal year 2022 budget by appropriating \$15,000 from the general fund, fund balance for contracting traffic control services in support of the 2022 Iron Dog snowmobile race being run from the Menard Center. The Iron Dog organizing members are seeking to have the official start and end at the Menard Center.

The Iron Dog organizing members have identified a route from the Menard Center to Big Lake that would require crossing five major roadways, including S Clapp Street and W Big Lake Road following Lucille Creek. This funding would be for contracting with a traffic control service to have flaggers and signs and the beginning of the race and return to the Menard Center for the finish.

If the race is canceled or moved from the Menard Center, these funds will not be disbursed.
