WHEREAS, the Wasilla City Council authorizes an award to contract with World Wide Technology, estimated at \$99,662; Bridge Data Solutions, estimated at \$56,428, both with purchasing agreements as allowed per WMC 5.08.100, sole source procurement.

NOW, THEREFORE, BE IT RESOLVED, that the Wasilla City Council authorizes the purchase of information technology services and equipment, and directs administration to award the necessary contracts to enhance emergency protocols that support a mobile workforce using CARES Act funding in an amount not to exceed \$200,000.

Dear Mayor Ledford and City Council Members:

First, I would like to introduce myself, I am Steve Stewart, IT Manager for the City of Wasilla. From the many duties of my position, one specific purpose of my position is to modernize and secure the IT infrastructure at the City of Wasilla (COW). As part of this modernization project, is the ability to have an agile and mobile workforce. COVID 19 or any other pandemic or emergency that may come about, the ability to be mobile and secure is paramount. COW should be ready to respond to any emergencies in the future by providing the ability for employees to work from almost anywhere with an internet connection. This project will allow the connection to the COW network without a need for a COW Laptop or VPN connection and a steppingstone to more mobility and modernization.

I am requesting an amount not to exceed \$200,000 from CARES Act monies to start this project. What this initial purchase will allow is the quicker more streamlined work from home (WFH) approach with enhanced security and reliability. This will create an infrastructure that can then be used to slowly increase the city's ability to be mobile with an eventual migration to more cloud-based services.

The details are as follows.

VMware Server farm environment to host VMware Horizon Virtual Desktop Instance and virtualized Servers to support VDI and increase the mobility of COW IT staff, by virtualizing servers it can be managed remotely. IT Staff will have the ability to spin up servers needed to support WFH efforts without the need to procure a physical device.

Netapp Storage Arrays. These storage appliances will store all the user data, virtual desktops, and server data. Another storage array will be installed at a remote site for disaster recovery scenarios and serve as the backup location of user's virtual desktops and user data.


Cisco Nexus switches, to interconnect server farm and storage array.

This project will take some time to be fully operational. Lead times on IT equipment are months out.

For Cares Act Funding, we need to procure this by December 31, 20121, and this project will need to be completed as soon as possible, with a deadline of September 30, 2022, with all funds paid.
