Summary Statement: Swickard Alaska II, LLC; formerly Alaska Sales & Service, has notified the City that the State of Alaska contract pricing for vehicles is in the process of negotiation. The ordering window to take advantage of the State of Alaska contract pricing for the model 2023 Police Tahoes will close in May 2022. Therefore, additional appropriation is necessary to facilitate the ordering of the vehicles in fiscal year 2022.

In the Proposed Biennial Budget, Operating and Capital for Fiscal Year 2023 and 2024, the Wasilla Police Department, Patrol Division allocated \$400,000 to purchase six (6) public safety vehicles. Ordinance Serial No. 22-11 proposes to appropriate \$200,000 in fiscal year 2022 and if adopted, administration would propose to reduce the fiscal year 2023 vehicle fund appropriation by (\$200,000) so that the fund balance of the Vehicle Fund can remain fully funded. This would be proposed, and action taken from Council during the normal budget hearings for fiscal year 2023.
