**SUMMARY STATEMENT:** The library applied for a \$7,000 Public Library Assistance Grant from the Alaska State Library. As the grant line item in the State Library's budget has not been fully funded for a number of years, and the money appropriated is not sufficient to fully fund the grants, regulations require that the State Library reduce each grant proportionally. As a result, the library has been awarded a grant in the amount of \$6,350 for FY2010, which will be spent on book and audiovisual materials for the library. The grant revenue amount was budgeted at \$6,250 for FY2010 with the opposing expenditure budgeted in Books & Periodicals. This Ordinance appropriates the excess revenue (\$100) and re-classes the expenditure budget from Books & Periodicals (\$6,250) to the PL Assistance Grant (\$6,350).
