SUMMARY STATEMENT: This ordinance appropriates funding for an Airport Train Station and Garden Terrace Water Main Extension on Abby Blvd. The Airport Train Station will function as an intermodal facility for train passengers, bus stop for MASCOT, and possibly a Share-a-ride van site at the airport.
