SUMMARY STATEMENT: The City of Wasilla Police Department wishes to amend the FY2010 Police Department budget by \$4,185. By accepting and appropriating the total funding of \$40,213 (\$36,028 previously budgeted in FY2010 plus an additional \$4,185) from the Department of Military and Veterans Affairs and the Division of Homeland Security and Emergency Management allows Mat-Com Dispatch to provide after hour answering for the State Emergency Communications Center (SECC) by providing a.5 FTE of a Call-Taker position, which will reduce the cost of funding the dispatch center for the City by \$40,213 or an additional \$4,185 from the FY2010 budget.
