SUMMARY STATEMENT: The City has a single grant that is designated for both water improvement projects along the Palmer-Wasilla Highway and at the Bumpus Recreation Complex. The water improvements along the Palmer-Wasilla Highway have been completed. Based on the bid results for the Bumpus Well Drilling project, the City is able to drill another production well at the site with this transfer of funds.
