- a. One (1) each operator's manual and tool kit (jack and wheel wrench) to be delivered with each vehicle.
- b. Vehicle shall include the following options:

  - iii. AMF Keyless entry
  - iv. 9G8 Delete daytime running lights
  - v. G80 Locking differential
