SUMMARY STATEMENT: The City obtained a \$75,000 grant from the State of Alaska in 2006 for a portable floor system to cover the ice rink for events needing a hard floor surface. The City has been researching alternatives and found new flooring systems cost approximately \$150,000. As such, a new flooring system is not obtainable with this grant. The City also looked local fabrication and found the units would be too heavy for changing out the floor on a routine basis.

The City has located a used light durable product that should last between 5 and 10 years that can be purchased for \$35,000 plus shipping that meets the requirements of WMC 5.08.140 for a sole source procurement (a used product at a discount rate).

The addition of a portable floor covering our facility will allow the facility to become a year round Ice Rink. Currently during the summer months, our regular customers transfer to Brett Arena for skating and hockey associated programs. With the additional 3 months of Ice we will add summer tournaments and camps along with associated open public skate and pick up leagues. Having fielded numerous requests by the users to provide these services, there is reasonable assurance of income to more than offset the extra 3 months of ice and maintenance.

Furthermore, with the addition of the floor covering we can provide alternative sports programs. Volleyball, indoor Soccer, Lacrosse, Rugby, Flag Football, etc. are all very successful in Anchorage and many of our local families currently travel there to participate in these programs. This equates to lost revenue for our City facility as well as local business. It further implies a short-fall in providing adequate options and opportunities to our local patrons.

The addition of the Arctic Predators Indoor Football League team will provide turf flooring to cover the portable floor at no cost to the City of Wasilla. This will be in their use agreement and contract. We are currently pricing sport court to use in conjunction with the flooring in order to place a bid for the Alaska State High School Volleyball Tournament for 2011-2013. This same sport court accompanied with portable Basketball Goals can offer us the potential to bid for local tournaments and community sports, thus mitigating the current loss of revenue to the private Sports Center on the Palmer-Wasilla Hwy.

The combination of these added events has potential to increase not only our financial earnings for the facility by nearly one-third, but more importantly expand our recreational and sports programs and events to a level in keeping with the needs of our community.




