A RESOLUTION OF THE WASILLA PLANNING COMMISSION APPROVING A REQUEST FROM NICK FONOV REPRESENTING FONOV INVESTMENTS. LLC: K & K ENTERPRISES; AND THE 42143 TRUST TO REZONE 10.7 ACRES FROM (RR) - RURAL RESIDENTIAL TO (C) - COMMERCIAL AND INCLUDING LOT 8D, BLOCK 1, WASILLA WOODS RSB; AND LOTS 9 AND 10, BLOCK 1, WASILLA WOODS SUBDIVISION WITHIN SECTION 3, TOWNSHIP 17 NORTH, RANGE 1 WEST, SEWARD MERIDIAN, ALASKA.

WHEREAS, Nick Fonov submitted an application for a zone change for Planning Commission Approval and recommendation to City Council to change the zoning from (RR) - Rural Residential to (C) - Commercial for Lot 8D, Block 1, Wasilla Woods RSB; and Lots 9 and 10, Block 1, Wasilla Woods Subdivision within Section 3, Township 17 North, Range 1 West, Seward Meridian, Alaska; together totaling 10.7 acres; and

WHEREAS, a zone change is reviewed and approved under the same process as conditional use permits by the Planning Commission and City Council; and

WHEREAS, Mr. Fonov submitted a letter requesting that the Planning Commission process his application that was filed on January 22, 2009, which included the application, narrative, and maps which address criteria listed in WMC 16.16.040; 16.16.050; and 16.16.070; and

WHEREAS, the Wasilla Planning Office mailed notices for this request to property owners within 1,200 radial feet of the proposed development; and

WHEREAS, the public hearing date and time was publicly advertised; and

WHEREAS, the Wasilla Planning Commission deliberated on this request taking account the information submitted into by the applicant. evaluation

recommendations of staff contained in the staff report, public testimony - both written

and verbal comments, the applicable provisions of the Wasilla Comprehensive Plan,

and other pertinent information brought before them; and

WHEREAS, the Wasilla Planning Commission has developed Findings of Fact,

attached as Exhibit A, to summarize the basic facts and reasoning of the commission:

and

WHEREAS, after due consideration, the Planning Commission hereby

determines that this application meets the approval criteria for a rezone.

NOW, THEREFORE BE IT RESOLVED, that the Wasilla Planning Commission

approves this request, Case No. R09-01 for Fonov Investments to rezone

approximately 10.7 acres on property described as Lot 8D, Block 1, Wasilla Woods

RSB; and Lots 9 and 10, Block 1, Wasilla Woods Subdivision within Section 3,

Township 17 North, Range 1 West, Seward Meridian, Alaska, with no conditions.
