AN ORDINANCE OF THE WASILLA CITY COUNCIL AMENDING WMC 2.44.010(B) EXTENDING THE TERM LIMIT OF SPECIAL PURPOSE COMMITTEE MEMBERS FROM ONE YEAR TO THREE YEARS.

Section 1. Classification. This ordinance is of a general and permanent nature and shall become part of the city code.

Section 2. Amendment of subsection. WMC 2.44.010(B) is hereby amended to read as follows:

B. Committees formed for a special purpose of limited duration pursuant to ordinance or resolution shall not be subject to the provisions of this chapter relating to term of service or termination. Terms of appointment shall expire upon completion of the special purpose, but shall not exceed **three** [ONE] years.

Section 3. Effective date. This ordinance shall take effect upon adoption by the Wasilla City Council.

SUMMARY STATEMENT: WMC 2.04.030 and WMC 2.44.050 stipulate three year terms for members of the City Council as well as City boards and commissions. However, currently WMC 2.44.010(B) stipulates that members of special purpose committees formed by ordinance or resolution shall have terms no longer than one year.

There are times when a special purpose committee may not complete their duties within the prescribed one year. Therefore, it is respectfully being requested that the terms of special purpose committee members be extended from one year to three years. This will allow adequate time for a special purpose committee to complete their task while at the same time aligning the special purpose committee member term limits with those of other City boards and commissions.
