NOW, THEREFORE, BE IT RESOLVED, that the Wasilla City Council supports the Wasilla Area Seniors, Inc., and their efforts to initiate a Health and Wellness Center to offer programs that will promote health and delay the onset of disease among seniors and residents living in the City of Wasilla.
