CITY OF WASILLA ORDINANCE SERIAL NO. 10-11

AN ORDINANCE OF THE WASILLA CITY COUNCIL AMENDING WMC 2.12.010, CONFLICT OF INTEREST, TO ALLOW FOR A COUNCIL MEMBER TO MAKE THE MAYOR AWARE OF A POTENTIAL CONFLICT OF INTEREST ON BEHALF OF ANOTHER COUNCIL MEMBER.

Section 1. Classification. This ordinance is of a general and permanent nature and shall become part of the city code.

Section 2. Amendment of section. WMC 2.12.010, Conflict of interest, is hereby amended to read as follows:

- A. City Council.
 - 1. A member of the city council shall declare a substantial

financial interest the council member has in an official action and ask to be excused from a vote on the matter.

a. In the event that a council member believes that paragraph 1 of this section has not been met; and when there is a reasonable belief that a conflict exists, a council member shall announce a potential conflict of interest on behalf of another council member.

2. The mayor shall rule on a request <u>for a council</u> <u>member to be excused from a vote which was made</u> by a council member [TO BE EXCUSED FROM A VOTE].

3. The decision of the mayor on a request by a council member to be excused from a vote may be overridden by the majority vote of the council.

4. A council member who has been excused from a voting on a matter under this subsection also shall abstain from the discussion of the matter, except that the council member may speak on the matter as a member of the public.

Other City Employees and Officials. A city employee or official, Β. other than a member of the city council, may not participate in an official action in which the employee or official has a substantial financial interest.

Section 3. Effective date. This ordinance shall take effect upon adoption by the Wasilla City Council.
