AN ORDINANCE OF THE WASILLA CITY COUNCIL AMENDING THE FY10 POLICE DEPARTMENT BUDGET BY ACCEPTING AND APPROPRIATING FUNDS FROM THE EDWARD BYRNE MEMORIAL JUSTICE ASSISTANCE GRANT IN THE AMOUNT OF \$22,017 TO COVER THE PURCHASE OF A VEHICLE FOR THE INVESTIGATION DRUG UNIT.

Section 1. Classification. This is non-code ordinance

Section 2. Purpose. To amend the FY10 Police Department budget by accepting and appropriating funds in the amount of \$22,017 from the Edward Byrne Memorial Justice Assistance Grant (JAG) program to the Police Department's budget for purchase of a vehicle for the Investigations Drug Unit. These funds are the remainder of funds accepted in Ordinance Serial No. 10-04, where the total was \$57,250 of which \$35,233 was appropriated for a digital evidence locker for the Police Department.

Section 3. Appropriation. The funds are appropriated to the following:


