SUMMARY STATEMENT: This grant has been available since 2005 to begin the construction of train station at the airport. The City has not been able to use the funding until the required match became available. The City acquired the necessary match last year from the State of Alaska. The project is now ready to begin with selection of a design firm.

An Action Memorandum will be presented for City Council approval of the design firm, once the RFP process is complete later in April or May. This funding will be needed to award the design contract. The current State and Federal funding (\$1.3 million) will complete the design, construct a gravel pad and build a train platform. Additional State Grants funds will be requested in the future to complete the project with paving, lighting, landscaping, and train station building. This station will be needed if the downtown station needs to be relocated or when commuter rail is viable. It will also serve as a bus transfer station and Share-A-Ride van pool operating area.

STAFF RECOMMENDATION: Approve the adoption of Ordinance Serial Number 10-15 that accepts and appropriates \$885,311 in Federal Transit Administration Funding for the Wasilla Intermodal Facility.
