

ADOPTED by the Wasilla City Council on October 8, 2007.

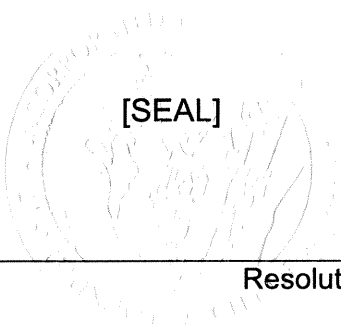
