WHEREAS, future funding for the firing range will be sought when it is determined that the project is feasible.

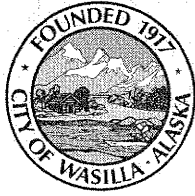

**SUMMARY STATEMENT:** The proposed FY2011 Capital Improvement Program budget includes funding for painting City Hall and Historic Townsite Restoration. However, painting and other work should be done in May and June before potential rains occur later in the summer. In addition, the administration has the opportunity to purchase the Old Wasilla Post Office for \$15,000 and move it to the Historic Townsite as an improvement.

It is anticipated that the \$50,000 transfer amount will be enough to paint the Teeland-Herning Building and to purchase the Old Wasilla Post Office. The painting of City Hall will likely have to wait until July 2010. The administration is having other Historic Townsite buildings painted before July 1, 2010 with volunteer help. Officers from the Wasilla Police Department have volunteered to paint the Teeland House and that work is currently underway.

Funding for the shooting range will be brought back for City Council approval once it has been determined to be a feasible project.

**STAFF RECOMMENDATION:** Approve the adoption of Resolution Serial No 10-17 transferring funds within an accounting fund in the amount \$50,000 for the exterior painting contract of City Hall and the Teeland-Herning Building, and Historic Townsite Improvements.
