AN ORDINANCE OF THE CITY OF WASILLA, ALASKA, PLACING THE QUESTION OF EXEMPTING MUNICIPAL CANDIDATES FROM THE CAMPAIGN DISCLOSURE LAW BEFORE THE VOTERS.

BE IT ORDAINED AND ENACTED BY THE CITY OF WASILLA, ALASKA, AS FOLLOWS:

SECTION 1. That the question of "whether or not to exempt its municipal candidates for elective office from the requirements of the State of Alaska campaign disclosure (AS 15.13)" shall be placed on the ballot at the regular election to be held on October 4, 1977.

ORDINANCE NO. W77-T-6

AN ORDINANCE OF THE CITY OF WASILLA, ALASKA, PROVIDING FOR THE LEVYING OF A TAX ON REAL AND PERSONAL PROPERTY.

Whereas the City of Wasilla, Alaska, has the authority under A. S. 29.53.410, 29.28.020 (b) and City of Wasilla Ordinance No. W75-0-1 Chapter X Sec. 10.4 and Chapter XII Sec.12.2 to call for a special ballot for levying taxes on real and personal property.

BE IT ORDAINED AND ENACTED BY THE CITY OF WASILLA, ALASKA, AS FOLLOWS:

SECTION 1. That on October 4, 1977 a ballot shall be presented on the question "Shall the City of Wasilla levy a tax on real and personal property within the City of Wasilla, Alaska, not to exceed 1/2 of 1% of assessed valuation."

SECTION 2. This Ordinance takes effect upon passage by the City Council.
