A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF WASILLA, ALASKA PLEDGING IMMEDIATE STEPS TOWARD THE FORMATION OF A CHARTER COMMISSION LEADING TO HOME RULE IF THE IMMEDIATE STEP OF FIRST CLASS CITY STATUS IS ACHIEVED.

WHEREAS, the City Council has determined that Home Rule is the best classification of local government to meet the needs of residents of the City of Wasilla; and

WHEREAS, an election has been ordered on First Class Status preparatory to Home Rule Status;

NOW THEREFORE BE IT RESOLVED, that if the First Class Election is successful, immediate steps will be taken to form a Charter Commission and all other steps required by law leading to Home Rule.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF WASILLA, ALASKA DIRECTING THE CITY CLERK TO PLACE ORDINANCE SERIAL NO. 83-30 BEFORE THE VOTERS AT A SPECIAL ELECTION NOVEMBER 8, 1983.

WHEREAS, the City of Wasilla contemplates installation of a public sewer system within portions of the City of Wasilla during the 1984 construction season; and

WHEREAS, it may become necessary to exercise the power of eminent domain to acquire rights-of-way across as yet unidentified property; and

WHEREAS, exercise of the eminent domain power must be submitted to the qualified voters of the City of Wasilla;

NOW THEREFORE BE IT RESOLVED, that the City Clerk is directed to place Ordinance Serial No. 83-30 before the voters at a special election November 1, 1983.

ORDINANCE SERIAL NO. 83-30

AN ORDINANCE OF THE CITY OF WASILLA, ALASKA TO EXERCISE THE POWER OF EMINENT DOMAIN.

BE IT ORDAINED AND ENACTED BY THE CITY OF WASILLA, ALASKA:

SECTION I. Classification. This ordinance is of a permanent nature and shall become part of the Wasilla City Code.

SECTION II. Exercise of Power. Upon adoption by the City Council and ratification by the voters the City of Wasilla shall exercise the power of eminent domain under the provisions of A.S. 09.55.

<u>SECTION III.</u> <u>Effective Date</u>. This ordinance shall become effective upon ratification by City voters.
