**A RESOLUTION OF THE WASILLA CITY COUNCIL ACCEPTING THE
CERTIFICATE OF CANVASS BOARD RESULTS AND CERTIFYING THE

2. That Dianne L. Woodruff was elected to Seat E, a three-year term ending October 2013, having received the greatest number of votes cast for Seat E.
3. That Steve Menard was elected to Seat F, a three-year term ending October 2013, having received the greatest number of votes cast for Seat F.
4. That Proposition No. 1, Exemption from Alaska Public Offices Commission requirements and creating a City Disclosure and Conflict of Interest Statement process. [Ordinance Serial No. 10-22(SUB)(AM)], failed.
