Mr. John Dewar:

- stated that he was in favor of the City of Wasilla taking over platting authority from the Matanuska-Susitna Borough;
- stated that he is in support of the LED signs that are within the City of Wasilla;

- stated that she is on the City Council but speaking as a concerned citizen;

Discussion moved to the Commission.

VOTE: The motion to adopt Resolution Serial No. 10-16 as presented passed unanimously.

2. **Resolution Serial No. 10-17:** Approving Variance #V10-01 allowing a five-foot reduction of the 25-foot front yard setback from the Lake Street right-of-way and a 35-foot reduction of the 75-foot shoreline setback for lots 1 and 2, block 8, Kennedy Addition to Wasilla Townsite Subdivision to allow for the construction of a single-family dwelling; generally located west of Knik-Goose Bay Road off of Lake Street (pending Matanuska-Susitna Borough Platting Division replat combining Lots 1 and 2, Block 8, Kennedy Addition to Wasilla Townsite Subdivision).

Ms. Crawford:

- stated per Wasilla Municipal Code the physical posting of the property was not done;
- stated her recommendation would be to open the public hearing to hear from the applicant and the public and then continue the public hearing for Resolution Serial No. 10-17 to November 9, 2010;
- advised that no action can be taken tonight; and
- handed out an updated Resolution Serial No. 10-17 and stated that the changes were not substantive but were only to correct the format of the resolution.

Mr. Steffan Frommer:

provided a brief history of himself;

- stated that he doesn't have any issues with the conditions recommended by the Planning staff; and
- provided a brief summary of his intent of use on the subject properties.

Discussion moved to the Commission.

c. Private person supporting or opposing the proposal

Chair Buswell opened the public hearing on Resolution Serial No. 10-17.

Mr. Dan Easley:

- stated that he is the neighbor immediately north of the subject lots;
- stated his concerns regarding the clear-cutting of Mr. Frommer's lot;
- stated his concern regarding the public notice and incorrect lot size information;
 and
- stated that he is not opposed to the variance just the size of the proposed structure.

Mr. Dewar:

- stated that he is a neighbor two lots to the north; and
- stated that he is opposed to the variance request.

There being no others present who wished to speak, Chair Buswell closed the public hearing on Resolution Serial No. 10-17.

d. Applicant rebuttal

Mr. Frommer:

- stated that his tree contractor cleared the lot inconsistent with his directions; and
- stated that he is working with the City Planner to develop a landscape plan to revegetate the lots.

MOTION: Commissioner Kelly moved to postpone Resolution Serial No. 10-17 to a time certain of November 9. 2010.

VOTE: The motion to postpone Resolution Serial No. 10-17 to a time certain passed unanimously.
