## SUMMARY STATEMENT:

Pursuant to WMC 2.08.090.D, Revisor of ordinances, the following editorial corrections to the Wasilla Municipal Code are being reported to the City Council and will be included in the next code supplement.

On May 14, 2007, Ordinance Serial No. 07-30 was adopted by the Wasilla City Council. This ordinance, in part, deleted WMC 6.04.060. However, it has been found that a reference to this old code section still exists in WMC 1.20.030, Disposition of scheduled offenses - Fine schedule. This is simply an update to the code to delete the incorrect citation (WMC 6.04.060) and to replace it with the correct citation (WMC 6.04.085).

## Amanda--

While incorporating Ordinance 10-30 into the code, we came across an old error in Section 1.20.030(C). The table of violations begins with WMC 6.04.060 for business license violations, a bad cross-reference that does not take into account the version of Chapter 6.04 set out in Ordinance 07-30 (which replaced the chapter in its entirety). We have currently left this as-is and recommend that the city amend the section at its convenience with a new ordinance to rectify the reference.

The online code should be updated shortly (probably late tomorrow).
