AN ORDINANCE OF THE WASILLA CITY COUNCIL AMENDING THE FY11 POLICE DEPARTMENT BUDGET BY ACCEPTING AND APPROPRIATING FUNDS FROM ALASKA DEPARTMENT OF TRANSPORTATION AND THE ALASKA HIGHWAY SAFETY OFFICE IN THE AMOUNT OF \$22,504 FOR THE ALASKA STRATEGIC TRAFFIC ENFORCEMENT PARTNERSHIP DRIVING UNDER THE INFLUENCE AND SEATBELT GRANT.

Section 1. Classification. This is a non-code ordinance.

Section 2. Purpose. To amend the FY11 Police Department budget by accepting and appropriating funds from the Alaska Department of Transportation and the Alaska Highway Safety Office in the amount of \$22,504 for high-visibility seatbelt and DUI enforcement.
