**SUMMARY STATEMENT:** Acceptance and appropriation of funds in the amount of \$18,426 received from the State of Alaska Department of Transportation and Public Facilities Highway Safety Office to be used for the Law Enforcement Liaison (LEL) program. Funding for FY 11project was \$17,772. An additional \$654 was received in FY 11 for reimbursement of funds relating to the previous fiscal year's grant; thereby adding to the amount, bringing the total to \$18,426.

Alaska Highway Safety Office (AHSO) is supporting the LEL program statewide and has requested Wasilla PD to represent the Central Region in the program. AHSO sought a 3-year commitment to the program and will fund the expenses incurred in participating in the program.
