**AN ORDINANCE OF THE WASILLA CITY COUNCIL AMENDING WMC 2.04.035, COMPENSATION AND REIMBURSEMENT, TO ESTABLISH AN ANNUAL RATE OF PAY FOR CITY COUNCIL MEMBERS.**

**Section 1. Classification.** This ordinance is of a general and permanent nature and shall become part of the city code.

**Section 2. Amendment of section.** WMC 2.04.035, Compensation and reimbursement, is amended to read as follows:

A. Council members shall be compensated **\$6,000 annually.**  
[TWO HUNDRED TWENTY-FIVE DOLLARS (\$225) FOR EACH  
REGULAR MEETING ATTENDED].

B. A council member may elect to purchase individual and related insurance coverage at their own expense.

**Section 3. Effective date.** This ordinance shall take effect on January 24, 2011.

**SUMMARY STATEMENT:**

Currently the City Council receives \$225 for each regular meeting attended. Typically, there are two regular meetings a month and an average one special meeting a month. As it stands today there is no compensation associated to attendance at special meetings or for attending a Matanuska-Susitna Borough Assembly Meeting as a City representative.

The proposed ordinance allows for a flat rate of \$6,000 per year equaling \$500 per month for City Council Member's compensation regardless of how many regular or special meetings attended as a body or as a representative during a Matanuska-Susitna Borough Assembly Meeting.
