- stated that he believes the City should move the boat launch; and
- stated that he is in opposition to the granting of the variance.

- stated that he has had discussions with the Mat-Su Borough regarding the high water mark;
- stated that he was told that surveyors that have worked in the area agree on the location of the high water mark is on Lucille Lake; and

- stated that she believes the definition that suits their use is vacation rentals.

Ms. Dianne Woodruff:

- stated that she is not representing the City Council;
- stated that her concern would be the application process and how to best notify the neighborhood when this type of use is being applied for.

Mr. Larry Ficek:

- stated he is in favor of this request; and
- stated that there are other uses in the area and it is only residential.

There being no others present who wished to speak, Chair Buswell closed the public hearing on AM No. 10-12.

MOTION: Commissioner Kelly moved to approve the interpretation that short-term rental of dwelling units is a permitted use in the R-2 zoning district.

Discussion moved to the Commission.

VOTE: The motion to approve the interpretation that short-term rental of dwelling units is a permitted use in the R-2 zoning district passed unanimously.

- stated that gas stations have animated signs and they are appearing more within the City Limits; and
- stated that the sign ordinance needs to updated.

Chair Buswell:

- asked about the status of a new Commissioner and any approval of new applications; and
- stated that the City of Wasilla is the leader in the Valley and people are satisfied with what is going on.
