SUMMARY STATEMENT: The State Legislature is considering Senate Bill 77 this year that will appropriate State funds to match local and federal funds used for public transit operating costs. This Bill will fund transit services such as People Mover, MASCOT, Valley Movers, and Van Pools used for public transit in our area.

These transit entities receive Federal Funding for operating costs, however, they also struggle to find the necessary match funding on an annual basis. This Bill will provide the necessary match funding and allow public transit to be stable and grow. In addition, this type of match funding is vital if commuter rail service between Wasilla and Anchorage is to become a reality.

STAFF RECOMMENDATION: Approve the adoption of Resolution Serial No 11-10 supporting Alaska Senate Bill 77 in the 27th State Legislature for transit matching funds.
