SUMMARY STATEMENT: In accordance with WMC 5.08.120, on December 4, 2007, the City issued Request for Proposal 0651-0-2007/WM for Insurance Brokerage Services (property, liability, automobile and workers compensation). Council adopted AM No. 08-25 on April 28, 2008, which provided a 3-year contract to Combs Insurance Agency, Inc., to expire June 30, 2011.

Additionally, on March 7, 2008, the City issued Request for Proposal 0693-0-2008/WM for Employee Benefits Consulting and Brokerage Services. The objective is to seek a

broker that will seek the best benefits and rates for the City, and serve as an independent focal point for all employee benefits and health insurance related matters. Council adopted AM No. 08-26 on April 28, 2008, which provided a 3-year contract to Combs Insurance Agency, Inc. to expire June 30, 2011.

Each contract provides the allowance for the City to extend each contract for a period not to exceed (1) additional 3-year term.
