**SUMMARY STATEMENT:** The Police Department received \$12,800 in private donations to support continuation of the canine program in knowing and planning for the retirement of the department's only canine (Bravo). In August - October of 2010, an officer traveled outside to purchase the new canine (Marshall) and to participate in the training of the dog. The total costs incurred for the purchase of the canine, travel, training and personnel overtime were approximately \$34,900 of which \$12,800 were covered by the private donations. The remaining \$22,100 is requested to be covered by the federal asset forfeiture funds which are available for certain law enforcement uses. These costs are in compliance with the permissible uses as indicated by the Finance Department's direct inquiry with the U.S. Department of Justice.

These costs were originally charged to the general fund (Wasilla Police Department) and upon approval of this ordinance would be transferred to fund 230 - the federal asset forfeiture fund. The costs in excess of \$12,800 were not included in the original FY2011 budget.
