**Section 1. Classification.** This is a non-code ordinance.

**Section 2. Purpose.** To amend the FY11 Police Department budget by accepting and appropriating funds from the State of Alaska, Department of Transportation and the Alaska Highway Safety Office in the amount of \$89,583 for high-visibility seatbelt and DUI enforcement. The total award amount from the Alaska Highway Safety Office was \$112,087 for FY11, of which only \$22,504 has been accepted and appropriated through legislation, leaving a balance of \$89,583.
