5. PUBLIC HEARING:

A. 1992 Public Improvements Plan/FY92 Capital Improvement Priorities

Mayor Stein opened the hearing to the public. No comments were made. Mayor Stein closed the hearing to the public.

B. Ordinance Serial No. 90-15; Annexing certain Land into the Corporate Boundaries of the City of Wasilla (Wasilla Lake)
Mayor Stein opened the hearing to the public.

Larry Heal: Opposed to annexation, this would put the City at their doorstep and the City would then govern their use of Wasilla Lake.

Helen Herrit: Opposed, would like to see if the regulations adopted for Wasilla Lake work.

Mel Husa: Questioned what would happen to private docks in Wasilla Lake and how the City would police Wasilla Lake without funds.

John Tull, Mat-Su Resort Manager: Opposed, could lead to annexation of property adjacent to Wasilla Lake.

Tom Tesenier: Opposed, people would not have representation by annexing Wasilla Lake, feels this will take the public use of Wasilla Lake away.

Mike Michaels: Opposed, concur with previous spéakers, annexation will take freedoms away.

Bill Herrit: Opposed, have already set forth regulations on lake uses, am totally against making Wasilla Lake a part of Wasilla

Ken DeCamp: Opposed to annexation, what is the real agenda?

Tim Brett: Opposed.

<u>Dean Beaulieu</u>: Opposed to annexing the Lake, if annexed the City Council should approach and allow all homeowners to vote on the issue.

Helen Herrit: Asked why this has come up?

Mayor Stein explained that this had begun prior to the Lake ordinance and the reasoning behind the idea.

Carroll Christensen: Opposed, object to added cost City would have, feels that the entire chain of lakes should be looked at as a whole and not just Wasilla Lake, eventually the entire chain of lakes should be placed under one governing body.

Mel Husa: Offer advantages of annexing people rather than annexing the lake.

No further public comments were made. Mayor Stein closed the hearing to the public.

C. Ordinance Serial No. 90-38; Setting forth the Regulations, Procedures, and Penalties pertaining to the collection of a Sales Tax in the City of Wasilla Mayor Stein opened the hearing to the public.

Jim Palin: Favors a sales tax because it is derived by the people using the facilities and is a good, fair source of revenue. Oil revenues are declining and the City needs to get in a position to pay its own way and by keeping the sales tax in the City the monies would be governed locally and benefits the City.

Tom Tesenier: Opposed to sales tax, does not want to support the City, lives from payday to payday and feels the City should also.

Rod Cottle: Stated he is speaking for himself and not his wife who is on the Council. Would vote for a sales tax, but not one exempting senior citizens. Hope the Council would support a reduction in property tax. Tourism is a big revenue in Wasilla and many of these are senior citizens.

Dean Beaulieu: Is a property owner and businessman in Wasilla and favors sales tax, as a former Planning Commissioner, know there are many Capital Projects needed such as a new Library which benefits all people. Also the sales tax is not that much, it has a \$10.00 ceiling on large item purchases.

Tom Smith: Opposed, lives outside City but is effected by what the City does. Came to the Valley for freedom and am starting to loose freedom. Sales tax is a cancer, don't let it get started it wont stop with 2%.

Richard Hart: Opposed, recently moved from a town in Nebraska where a sales tax was started, business revenues dropped 50% in the first two years. Sales tax is there forever, it never decreases.

Sam Grimes: Opposed, would probably get support if Council specified what it would be used for.

Chuck Steelstra: Opposed to sales tax, recognizes the City needs to pay its way but feels sales tax is wrong way to do that. Would be willing to pay more in property tax and suggested making higher user fees and let the users pay their own way. Favors higher business license fees and possibility of a two tier property tax.

Ken DeCamp: Opposed, agrees with other comments made, feels its important to consider the impact on everyone and is not sure people are getting the level of service for what is currently being paid in property tax. Suggested there are other ways of gaining more revenue such as selling the public land the City owns and getting that in to the tax base.

June DeArmun: Opposed to sales tax, businesses are just starting to come out of recession, business is looking up but not with additional 2% sales tax. Raise property tax if you must. Feels that as non-resident property owners they are being taxed without representation.

Stan Hintzman: Opposed, agree with most of the comments made.

Bill Byers: Opposed, don't want any more taxes, feels the City is heading in the wrong direction.

Rocky Spear: Opposed to sales tax, feels there are a lot of things that Palmer doesn't get that Wasilla does because of the sales tax. Stated he would spend his last dime fighting this sales tax.

Morris Matthews: Favors sales tax, State revenue sharing is non existent, favors help in relief of property tax. Feels the City needs to get information out to the public so people understand.

Gary Weber: Opposed, will not raise prices to cover added expense of sales tax.

Rod Cottle: Favors the ordinance as its presented, feels that a simple majority vote for all offices is enough.
