


SUMMARY STATEMENT: Currently, the Police Department uses a Conex container at the public works yard for the storage of evidence. The Police Chief has identified a area at the police station within the security fencing for the radio tower for 2 small Conex containers for the storage of evidence and ammunition. The proposed storage containers will be more efficient and secure being located at the police station.
