We're pleased to present to you this year's Annual Quality Water Report. This report is designed to inform you about the quality water and services we deliver to you every day. Our constant goal is to provide you with a safe and dependable supply of drinking water. We want you to understand the efforts we make to continually improve the water treatment process and protect our water resources. We are committed to ensure you the best water quality possible.

As water travels over the land or underground, it can pick up substances or contaminants such as microbes, inorganic and organic chemicals, and radioactive substances. All drinking water, including bottled drinking water, may reasonably be expected to contain small amounts of contaminants.

The presence of these contaminants does not indicate that water poses a health risk. Some people may be more vulnerable to contaminants in drinking water than the general population. Immune-compromised persons such as persons with cancer undergoing chemotherapy, persons who have undergone organ transplants, people with HIV/AIDS or other immune system disorders, some elderly, and infants can be particularly at risk from infections. Wasilla Public Water System consists of 5 well sites with one more scheduled. Water is supplied through 4 atmospheric storage tanks providing pressure throughout the distribution system. For those customers east of the Wasilla Police Station to Seward Meridian Parkway maintain working pressure by means of two booster pumps.

We routinely monitor for contaminants in the drinking water according to Federal and State laws. The tables reflect the results of our monitoring for the period of January 1st 2007 to December 31st, 2007 or the most recent monitoring results.

We here at the City of Wasilla work to provide top quality water to every tap.

In the wake of 9-11 we ask that all our customers help us protect your water sources, which are the heart of our community, our way of life and our children's future.

We have learned through our monitoring and testing that some contaminants have been detected as indicated in this table.

We are please to report that no violations or deficiencies were noted for the Wasilla Public Water System in 2007 to report. Waivers and/or non-detects: There are many regulations pertaining to sampling and monitoring of our water system. Since we have a waiver for Synthetic Organic Contaminants, Other Organic Contaminants, and Asbestos, we were not required to test for them during the time period covered by this report.

To help you better understand these terms we've provided the following definitions:

Non-Detects (ND) - laboratory analysis indicates that the contaminant is not present.

Parts per million (ppm) or Milligrams per liter (mg/l) - corresponds to one part per million parts.

Parts per billion (ppb) or Micrograms per liter (ug/I) - corresponds to one part per billion parts.

Nephelometric Turbidity Unit (NTU) - nephelometric turbidity unit is a measure of the clarity of water. Turbidity in excess of 5 NTU is just

noticeable to the average person.

<u>Action Level (AL)</u> - The concentration of a contaminant which, if exceeded, triggers treatment or other requirements which a water system must follow.

<u>Treatment Technique (TT)</u> - A treatment technique is a required process intended to reduce the level of a contaminant in drinking water. <u>Maximum Contaminant Level (MCL)</u> - The "Maximum Allowed" is the highest level of a contaminant that is allowed in drinking water. MCLs are set as close to the MCLGs as feasible using the best available treatment technology.

<u>Maximum Contaminant Level Goal (MCLG)</u> - The "Goal" is the level of a contaminant in drinking water below which there is no known or expected risk to health. MCLGs allow for a margin of safety.

<u>Lead and Copper Information</u>: A small number of the households in our area are tested for lead and copper periodically. It is possible that lead or copper levels at your home may be higher than at other homes in the community as a result of materials used in your home's plumbing. Infants and young children are typically more vulnerable to lead in drinking water than the general population. If you are concerned about elevated lead or copper levels in your home's water, you may wish to have your water tested, and flush your tap for 30 seconds to 2 minutes before consuming tap water.

<u>Arsenic Information</u>: "While your drinking water meet's EPA's standard for arsenic, it does contain low levels of arsenic. EPA's standard balances the current understanding of arsenic's possible health effects against the cost of removing arsenic from the drinking water. EPA continues to research the health effects of low levels of arsenic, which is a mineral known to cause cancer in humans at high concentrations and is linked to other health effects such as skin damage and circulatory problems".

<u>Radon Information</u>: Radon is a naturally occurring radioactive, dense, colorless, and odorless gas. Research has linked radon in air, and to a much lesser extent drinking water, to increased chances of respiratory illness and at least two types of cancer (lung and throat). Radon is not currently a regulated drinking water contaminant, however, the Radon Rule has been proposed by U.S. EPA to regulate radon in drinking water.
