ORDINANCE SERIAL NO. 11-29**

AN ORDINANCE OF THE WASILLA CITY COUNCIL AMENDING WMC 3.60.060, HOLIDAYS WITH PAY, TO ALLOW FOR BOTH EIGHT AND TEN HOURS OF COMPENSATORY TIME.

Section 1. Classification. This ordinance is of a general and permanent nature and shall become part of the city code.

Section 2. Amendment of section. WMC 3.60.060.A, Holidays with pay, is hereby amended to read as follows:

A. The following days shall be recognized as holidays that are compensated with eight or ten (10) hours of regular pay for all employees, except temporary, non-regular hourly, and intern employees, who are in pay status before and following such days:

Section 3. Effective date. This ordinance shall take effect upon adoption by the Wasilla City Council.

SUMMARY STATEMENT:

Currently WMC 3.60.010 states in part: A. Regular working hours of city employees shall consist of either five consecutive days of eight hours per day or four consecutive days of ten (10) hours per day.

However, when referencing WMC 3.60.060, Holidays with pay, this section of code does not allow for a ten hour work day.

This ordinance is being brought forward for consideration to make this section of code consistent with WMC 3.60.010.
