The Regular Meeting of the Wasilla City Council was held on Monday, January 23, 2012, at the Wasilla City Council Chambers, Wasilla, Alaska. Mayor Verne E. Rupright called the meeting to order at 6:03 p.m.

Mayor Rupright asked Mr. Alvah Clark Buswell, III, Planning Commissioner, to lead the Pledge of Allegiance.

Mayor Rupright asked for a moment of silence in recognition of the life of Mr. Erling Nelson who recently passed away.

- 1. **Ordinance Serial No. 12-02:** Repealing Resolution Serial No. 11-36 and creating an Ethics Task Force and prescribing its duties. *(Sponsored by Council Member Woodruff)*

Mayor Rupright opened the public hearing on Ordinance Serial No. 12-02.

Ms. Mary Kvalheim opined that council members should not be members of the Ethics Task Force.

There being no others present who wished to speak, Mayor Rupright closed the public hearing and discussion moved to the Council.

MOTION: Council Member Woodruff moved to adopt Ordinance Serial No. 12-02.

Discussion ensued.

MOTION: Council Member Woodruff moved a primary amendment to:

The fifth WHEREAS clause, to replace the words "two City of Wasilla council members and three" with the word "five" and to read as follows:

"WHEREAS, to provide balanced view on the standards of ethics the Task Force shall be composed of five City of Wasilla residents; and"

The seventh WHEREAS clause, to delete the words "that WMC 2.44.030(A) shall not apply to the Task Force Members who are Council Members, who shall be chosen among themselves by the council, and except" and to read as follows:

"WHEREAS, the Task Force shall be subject to the provisions of WMC 2.44, Boards and Commissions Generally, except for the provisions of WMC 2.44.040(B); and"

Section 2. Purpose, to delete the words "members as follows:

A. Two City Council members; and

B. Three" and to read as follows:

"**Section 2. Purpose**. The Ethics Task Force is hereby created for the purpose of gathering information and making recommendations to the City Council concerning a code of ethics for the City of Wasilla. Furthermore, the Task Force shall forwards its recommendations to the Council; and the Task Force shall consist of five City of Wasilla residents."

VOTE: The primary amendment passed unanimously.

VOTE: The motion to adopt Ordinance Serial No. 12-02(AM) passed unanimously.

Ms. Smithers noted that Ordinance Serial Nos. 12-03, 12-04, 12-05, 12-06 and 12-07 would be taken together in one motion.

Discussion ensued regarding Ordinance Serial No. 12-05.

VOTE: The motion to adopt Ordinance Serial Nos. 12-03, 12-04, 12-05, 12-06 and 12-07 passed unanimously.

MOTION: Council Member Sullivan-Leonard moved to adopt Ordinance Serial No.

VOTE: The motion to adopt Ordinance Serial No. 12-08 passed unanimously.

Mayor Rupright opened the public hearing on Ordinance Serial No. 12-09.

Mr. Kevin Baker:

- stated that he represented Mr. Gary Lundgren, landowner:
- spoke to the current zoning request;
- noted that this rezone failed at the Planning Commission level due to a failure for four affirmative votes;
- added that three planning commissioners voted in favor and one commissioner was in opposition, the remaining two were absent; and
- asked for the Council's support on Ordinance Serial No. 12-09.

Ms. Tina Crawford, City Planner, provided a staff report.

There being no one present who wished to speak, Mayor Rupright closed the public hearing and discussion moved to the Council.

MOTION: Council Member Woodruff moved to adopt Ordinance Serial No. 12-09.

Discussion ensued.

VOTE:

The motion to adopt Ordinance Serial No. 12-09 failed with Council Members Holler, Katkus and Sullivan-Leonard in opposition and Council Members Harris, Menard and Woodruff in favor. [CLERK'S NOTE: Per WMC 2.04.130, four affirmative votes shall be required to carry any measure before the Council.]

(The regular meeting recessed at 7:13 p.m. and reconvened at 7:20 p.m.)

Ms. Elsie O'Bryan commented on the Friendship Christmas Dinner which took place on December 25, 2011, at the Curtis D. Menard Memorial Sports Center and served approximately 2,850 people.

Ms. Heather Vest:

- spoke to an incident which occurred at the Curtis D. Menard Memorial Sports Center (Sports Center) on Saturday night, January 21, 2012;
- explained to the City Council the events surrounding the incident which involved her minor child; and
- asked the City Council to ban alcohol sales when there are simultaneous events occurring at the Sports Center where children may be present.

Council Member Woodruff requested an action plan be brought forward from administration regarding the security at the Sports Center when there are mixed events where alcohol sales will be available at one or both of those events.

Deputy Mayor Holler additionally requested a complete follow-up of this situation.

There was no objection noted to either request.

Council Member Katkus requested the Mayor look into how to promote events at the Sports Center without having liquor sales.

Mr. Payne:

- provided an update on the firing range appeal; and
- commented on the proclamation that was presented this evening.

Ms. Smithers:

- noted that early voting is currently occurring in the Clerk's Office between the hours of 8 a.m. and 5 p.m., Monday through Friday, and on Saturday, February 4, 2012, from 10 a.m. to 2 p.m.;
- commented on Alaska Public Offices Commission (APOC) reporting; and
- noted that there was training available on the new APOC requirements this Thursday, January 26, 2012, at the Regan Building on the Palmer-Wasilla Highway.

XIV. COUNCIL COMMENTS

Council Member Katkus:

- stated that she was saddened by the events that went on at the Sports Center this weekend;
- opined that alcohol sales have to stop at the Sports Center;
- stated that the City should not promote events that have alcohol sales; and
- commented on the volunteers who participated in the Christmas Friendship Dinner.

Deputy Mayor Holler stated that he would be working with Mr. Hastings on several issues he has.

Council Member Sullivan-Leonard commented on the passing of Mr. Erling Nelson.

Council Member Woodruff:

- spoke to the proclamation that was presented this evening;
- noted that Mr. Erling Nelson would be missed;
- stated that alcohol sales at the Sports Center is a liability issue; and
- commented on the Christmas Friendship Dinner and their Christian beliefs.

Council Member Harris:

- stated that she was appalled at the events of that occurred at the Sports Center over the weekend;
- extended her apology to Ms. Heather Vest; and
- inquired who had the caterers permit for the sale of alcohol at the Sports Center.

Mr. Hastings stated that it was The Mugshot.

Council Member Menard:

- noted that the Council and the City can learn from the event which took place at the Sports Center so it does not happen again in the future; and
- extended his apologies to Ms. Heather Vest.

Mayor Rupright:

- stated that the Whispering Woods Subdivision has contacted the City and would like to be annexed into the City;
- noted that the City of Wasilla will be challenging the U.S. Census' accounting of the City's population; and
- noted that the Police Chief is investigating the event which happened at the Sports Center.
